In pursuance to Regulation 50 of SEBI Listing Regulations (LODR), we hereby intimate you that, the Company has secured an approval from its Board of Directors to borrow funds by issue of secured redeemable non-convertible debentures including market linked debentures on private placement basis, in one or more tranches, upto Rs.17,000 crore ("Issue") at their meeting held on April 15, 2019. And that, the BSE has provided an in-principle approval for this Issue vide its letter dated April 13, 2020.

The Company now intends to raise its 10th tranche of Rs. 750 crore (plus Green Shoe Option of Rs. 450 crore to retain total subscription upto Rs.1200 crore). The securities under this Tranche would be allotted by the consent of the Debenture Allotment Committee on April 28, 2020. Kindly take the same on record.
