In pursuance to Regulation 50 of SEBI Listing Regulations (LODR), we hereby intimate you that, the Company has secured an approval from its Board of Directors to borrow funds by issue of secured redeemable non-convertible debentures including market linked debentures on private placement basis, in one or more tranches, upto Rs.17,000 crore ("Issue") at their meeting held on April 15, 2019 and May 13, 2020. And that, the BSE has provided an in-principle approval for this Issue vide its letter dated May 19, 2020.

The Company now intends to raise its 13th tranche of Rs. 100 crore (plus Green Shoe Option of Rs. 400 crore to retain total subscription upto Rs.500 crore).
