In pursuance to Regulation 50 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we hereby intimate you that, the Board of Directors of the Company has approved to borrow funds by issue of secured redeemable non-convertible debentures on private placement basis, in one or more tranches, upto Rs. 5,000 Crore ("Issue") at their meeting held on April 16, 2022. The BSE has provided an in-principle approval for this issue vide its letter dated April 10, 2023.

The Company now intends to raise its 3rd tranche of Rs. 450 crore plus green shoe option of Rs. 1,150 crore under this tranche and would be allotted by the consent of the Debenture Allotment Committee on May 30, 2023.
