In pursuance to Regulation 50 of SEBI Listing Regulations (LODR), we hereby intimate you that, the Company has secured an approval from its Board of Directors to borrow funds by issue of secured redeemable non-convertible debentures on private placement basis, in one or more tranches, upto Rs. 10,000 crores ("Issue") at their meeting held on July 16, 2021. And that, the BSE has provided an in-principle approval for this Issue vide its letter dated May 23, 2022.

The Company now intends to raise its 2nd tranche of Rs.100 crore plus green shoe option of Rs.900 crore. The securities under this Tranche would be allotted by the consent of the Debenture Allotment Committee on May 26, 2022. Kindly take the same on record.
