In pursuance to Cl. 50 of SEBI Listing Regulations (LODR), we hereby intimate you that, the Company has secured an approval from its Board of Directors to borrow funds by issue of secured redeemable non-convertible debentures on private placement basis, in one or more tranches, upto Rs.7000 crores ("Issue") at their meeting held on April 14, 2016. And that, the BSE has provided an in-principle approval for this Issue vide. its letter dated September 22, 2016.

The Company now intends to raise its Twenty Fourth tranche of Rs.110 crores with Green Shoe Option to retain over-subscription upto Rs.150 crores, in aggregate on private placement.
