Kindly ignore our previous letter dated 28.05.2018 in this regard and consider this revised letter.

In pursuance to Regulation 50 of SEBI Listing Regulations (LODR), we hereby intimate you that, the Company has secured an approval from its Board of Directors to borrow funds by issue of secured redeemable non-convertible debentures on private placement basis, in one or more tranches, upto Rs.7500 crores ("Issue") at their meeting held on April 18, 2017. And that, the BSE has provided an in-principle approval for this Issue vide. its letter dated April 23, 2018.

The Company now intends to raise its Eighth tranche of Rs.400 crores (plus Green Shoe Option to retain oversubscription upto Rs.700 crores). The securities under this Tranche would be allotted by the consent of the Debenture Allotment Committee on June 01, 2018. Kindly take the same on record.
